Domestic Abuse tool-kit recently launched at House of Commons

Over recent years we have helped an increasing number of people deal with the devasting effects of domestic abuse. Most have to flee their homes leaving behind everything including their family and job to be safe. We have helped these people start again by financing their new life but starting again emotionally is much more difficult.

That's why we've sponsored the Domestic Abuse toolkit. Created in partnership with Business in the Community (BITC) and Public Health England (PHE) the tool-kit was launched to the insurance industry on June 26 at the House of Commons. Victoria Atkins MP also gave an update on the forthcoming Domestic Abuse Bill.

Emily's story

E mily has worked in insurance since leaving school in 2010. Her parents split up a few years ago just after her mother had been diagnosed with cancer. The family home was repossessed and Emily and her mother moved in with her grandparents.

In spite of treatment and surgery, Emily's mother sadly died earlier in the year. She left no significant estate and Emily was not eligible for help with the funeral account. She was desperate when she contacted us; feeling she had let everyone down by not having enough to pay for her mother's cremation. Members agreed to clear the balance owed which gave Emily great comfort. She still needs to come to terms with the many traumatic months of seeing her mother's health decline and her subsequent bereavement but feels like a great weight has been lifted from her shoulders.
