- **You work in any section of the industry, whether purely technical or from other area's such as operations, IT etc**
- **Please note, you do not have to be a CII or PFS member**
- **Be able to demonstrate ways in which you have contributed to the industry. i.e work projects, mentoring etc**
- **Can demonstrate examples of charitable work whether it be in the industry or outside of Insurance**
