Dear Member,

Please see below the annual report from The Personal Finance Society Hants and Dorset Regional Committee to the Annual General Meeting of the Insurance Institute of Southampton, Friday 1st May 2020.

Since the last AGM on April 2nd 2019, the PFS Hants and Dorset Regional Committee have organised for its membership in both Hampshire and Dorset a total of 21 CPD pre-exam training days and a very successful Corporate Protection Day Conference in October 2019. Of these events 11 were hosted in Hampshire and 10 in Dorset. A total of 126 delegates attended the 21 exam workshops and 100 delegates attended the conference.

Unfortunately since March 16th 2020 due to the COVID-19 pandemic, we have had to curtail our extensively planned 2020 Q1 and Q2 programme of 14 events, of which only 3 were held prior to the lockdown. As a result the PFS Regional Committee have been planning a distance learning alternative for most of our events and this will be launched next week during the first week of May 2020.

The PFS Regional Committee also decided following their committee meeting in December 2019, to reduce the fees for all the RO, CF and JO exam courses in Q1 and Q2 2020 to just over £41 from £76.27 and increase the fees for the AF exam course to just over £81 from £76.27.
