Certificate & Diploma

The Certificate will be awarded by way of examination



- This exam will be at "A" level standard so all those employed in the sector should be capable of passing with 75 to 100 hours of study [4hrs per unit]
- The exam will consist of 50 multiple choice questions and a pass rate of 75% will be required. GTA will provide delivery and accreditation of the exam

Diploma

 The diploma will require a 3000 word dissertation on a choice of topics determined by GIIA and Sagacious Group. The award of the diploma will be assessed by a panel provided by GIIA, GTA and Sagacious Group

- Self study of course material available on-line
- Access to a mentor

- Multiple choice exam available in July each year @
- Diploma available from September 2023
