Education and Community Engagement

The Insurance Institute Liverpool (IIL) has been very active over the past few months, with James and Carly attending their second virtual visit to Liverpool John Moores University talking about careers in both Financial Planning and Insurance. We have also held the annual 'careers event' aimed at raising the profile of Insurance and Financial Planning to students in Year 12 and 13 and showing them how rewarding careers in the two professions can be. After a pause for 2 years, it was great to be back!

The full day event focused around the Discover Risk and Discover Fortunes board games, with the sessions being delivered by local Education Champions. The students were divided into small groups, working together with the support of a professional in the area to solve 'risk' and 'fortunes' problems, from assessing risk probabilities to how much of a pot to invest or save. The aim of the games being to beat other teams by getting as close to the correct answers as possible.

By playing both board games, students gain a greater understanding of what skills are needed to work in the sectors – from the analytical to team working to being able to effectively present your views to a group of peers. The focus is on developing their soft skills which are hugely important when entering the world of work.

Students also had the opportunity to hear from professionals working in both Insurance and Financial Planning, firstly from a graduate about her experience from school to university and then to obtaining Diploma qualifications. Students also heard from our very own Jack Steel, and this year's IIL president on his own journey from History degree to Chartered Major Loss Adjuster and the President of the Insurance Institute of Liverpool.

The day concluded with some 'speed networking', giving students the opportunity to speak to local professionals about their job roles, prospects and how they can get work experience and apprentice roles within the professions.

Having had to put the event on hold for the last two years due to Covid-19, it was Jack's focus for his Presidential year to run this successful event once again this year.
