## Importance of professionalism

- Challenging times since 2007
- Conduct regulator's focus on higher standards, ethics and moral judgment

 A clear need to build customer confidence and trust, while delivering better outcomes



## The Aldermanbury Declaration

"A practical framework for embedding professionalism into general insurance"

 Evidence of the insurance sector voluntarily embracing the challenge of raising standards of competence



## Chartered status – The gold standard

- Over 22,000 individual chartered practitioners and over 750 chartered firms
- Brand is widely recognised as a 'kitemark' for professionalism
- Independent research shows that consumers recognise and value the Chartered marque as an indication of merit, capability and commitment to ethical behaviour





## **Corporate Chartered Title review**

Chartered firms tell us that standards must be robust and relevant

- To retain public confidence, performance against criteria must be rigorously assessed
- In 2014 CII started to explore how corporate Chartered status could be enhanced



### **Professional Qualifications - GI**

- Changed completion requirements: Advanced Diploma in Insurance from January 2017:
- -150 Advanced Dip level credits (currently 90)
- An additional compulsory units (one of either: broking, underwriting or claims)

- Enhanced subject offering
- Enhanced assessment methods
- Withdrawal of financial services credits



### **Professional Qualifications - FS**

#### Investment/securities-focused diversification post-RDR

- L4 Certificate in Securities Advice and Dealing
- L4 Certificate in Discretionary Investment Management
- L3 Certificate in Investment Operations

#### Launched since 2014

- L3 Award in Retail Banking responding government's Banking Standards Review
- L3 Certificate in Financial Services eventually replacing the Certificate in Financial Planning for non-advisory staff.
- L4 Certificate in Advanced Mortgage Advice covering MMR changes
- L4 unit covering pensions reforms April launch
