Education Secretary

The Education Secretary is a means by which the Chartered Insurance Institute is able to deliver their educational initiatives locally, including the Discover Risk campaign in schools and colleges, and of course, the preparation and management of a local examination centre. The post also channels queries from representatives of local financial services businesses and / or the individuals themselves who are seeking a point of reference with the CII centrally.

The Examination Centre continues to share facilities with other professional establishments like CIMA and the University of Northampton. While voluntary Invigilators from our industry have been crucial to the running of the examination sessions historically, with less people working locally to the centre and the need for multi gender support, it had been difficult to obtain invigilators to meet the regulatory standard set by CII. The current examination centre is able to provide our invigilation requirements including the often last minute request for additional rooms and/or extra time where the invigilators must stay on in support of reasonable adjustment candidates. Increasingly examinations are becoming more coursework assessment based lessening the number of candidates attending formal

examinations. There are also 'on line' centres for certain examinations and we continue to strive to hold these sessions locally.

To those who have just sat their written examinations this week I wish you all good grades and completion of this step towards your qualifications. Please also take the opportunity to feedback to me your thoughts about the existing examination venue and what you would like to see for the future.
